This copyright is and shall be protected under U.S. and International copyright law. All rights to this material are exclusively owned and reserved by Intuitivethot ("**COPYRIGHT HOLDER**") except to the extent that the right to use such material is specifically granted by this license and/or Intuitivethot. *(In simple English: The goods delivered by us to you are totally protected by copyright law and you are not allowed to use these goods just for anything, and in any way. PROVIDED:

1. The **WORK** is not sold or distributed as a single entity, image, clip, frame, background, effect or data as part of any compiled library, collection, assortment, set or product. *(In simple English: This product and any of its contents may not be re-sold under any circumstance as standalone items or as part of a compilation designed for resale purposes. The good news is that you may use the goods in your productions to your heart's content, and as many times as you wish. And yes, as long as your production is not one that fits into the named categories, you should be fine at selling your production without further issues.)*

2. You indemnify and hold harmless **COPYRIGHT HOLDER** for any and all losses, damages, liabilities, claims, costs or expenses incurred directly or indirectly by you in

If it ends up costing you your livelihood, life, finances or anything else that may be detrimental, don't come back and blame it on us. You agree with this document and by using anything provided here that you take full responsibility for your actions. Even if our stuff blows up during use or fails to perform in any way, you still take full responsibility and cannot come back to us for any help, financial support or even testimony on behalf of your defense.)*

SO, YOU MAY:

1. 3. **In the case of a commercial video production, THE DATA** may be used, altered, or incorporated according to the guidelines described herein into any **WORK** (including commercial broadcast, commercial production, industrial and educational) that is created, produced, published or presented by **YOU provided you give us credit in the credit roll as is typically done by practice in the industry.** *(In simple English: again, as with most intellectual property products, you can't just freely distribute and use this amongst many users. You can however integrate the data into a production that is of a commercial nature such as a movie, indy, corporate video, infomercial or any other production designed for distribution as a published event for profit and some cases non-profit, provided you include us in your **credit roll** as follows:*
 - a. **"(Some) B-Roll provided by VaderVideo, a product of Intuitivethot – www.vadervideo.com.**
 - b. **"(Some) 2nd unit video provided by VaderVideo, a product of Intuitivethot – www.vadervideo.com.**
 - c. **"(Some) stock footage provided by VaderVideo, a product of Intuitivethot – www.vadervideo.com.)**
 - d. **Or any other valid definition that will allow for proper credit in such production.**

4. The above items hold true except for the following situations: (*In simple English: Pay particular attention to the next section.*)

YOU MAY NOT:

1. Use or transfer **THE DATA** and/or copies thereof, with the intent or result being that such use or transfer shall be in any form of a library, catalog or collection of **THE DATA**, whether in the form of deliverable media (CD, DVD, Tape, or readable memory of any kind) or in the form of electronically transmitted units (downloading, bulletin boards, etc.) or any form which in any way is similar and could conduce damage to our profit or competes with COPYRIGHT HOLDER. (*In simple English: If you want to create a library and sell it, go ahead. Just don't try to include any of our stuff or data within it. That would be major copyright infringement and we would come after you. 2. Transfer **THE DATA** to third parties through the use of on-line services or networks. (*In simple English: No, you may not put this stuff online for sale anyplace. Even if you are done using it.
